The group discussed that it might be useful to hold an event that educates town officials, board volunteers, and others about how the legislative process works in detail. This could be a good occasion to invite selected legislators to actually speak.

After much discussion, the group decided to hold such an event this spring. Leon will ask Senator Brewer (D) and Kathy will ask Representative Peterson (R) to speak. The event will be held on a Friday morning in April or May. They will be asked to speak about the legislative process with a target audience of town officials, board volunteers in Central Massachusetts.

In the fall, another topic chosen from the legislative priorities will be selected as a focus of the fall legislative breakfast. Two options discussed are the municipal relief through regional collaboration or something related to municipal health care reform or Other Post Employment Benefits (OPEB).

We also discussed asking our legislators to tell us what their priorities are, what their areas of expertise are, what their backgrounds are, etc.
