

TPAG Meeting Minutes  
July 30<sup>th</sup>, 2025

**Discussion/Approval of May Minutes**

Ms. Strzalkowski moved to approve the minutes of the May meeting, this was seconded by Ms. Mary Haroyan. All attendees voted in favor of approving the minutes.

**Paratransit Report**

Carolyn Foley from PBSTM read the statistics and figures from June FY25 as follows.

- Total Application Trips Requested: 77
- Total Trips Requested: 14,422
- Capacity denials: 0
- Cancellations: 3,255 (22.5% of scheduled trips)
- No Shows: 376 (2.6% of scheduled trips)
- Missed Trips: 2
- Trips Completed: 10,791
- Companions: 444
- PCA(s): 915
- Elder Shopper: 203

**New Statewide Paratransit Eligibility Application**

Starting July 1<sup>st</sup>, 2025, all Massachusetts RTAs will be using the same paratransit eligibility application. The application and instructions are available on the WRTA website and can be mailed if requested. Carolyn Foley (PBSTM) explained that paratransit applicants are no longer *required* to come in person to fill out the application. They may apply online or request the application by mail or come in person.

Review of process for expedited ADA Paratransit Eligibility application.

Concerns about the new Yellow Cab app which is not working properly for some users, especially related to text messages.

**Nomination of TPAG Officers**

The elections will be held in October, and nominations for Chair, Vice-Chair and two Executive Board members are now open

The attendees nominated Mike Kennedy for the executive board, he accepted.

Nancy Garr-Colzi was also nominated for Exec Board, she will be contacted to see if she accepts. [Subsequent to the meeting, Ms Garr-Colzie was contacted and accepted the nomination.]

### **Paratransit Customer Satisfaction Survey**

A TPAG member reports that 597 surveys were completed. WRTA will be reaching out to the individuals who received the survey but who have not yet completed it.

### **WRTA Customer Service Report**

In June there were 64 complaint cases closed – 27% related to paratransit

- 5 referenced driver's behavior
- 2 referenced driver being early/late
- 8 classified as 'other'

Shout out to paratransit driver Nick who offers exceptional service.

### **TPAG changes in 2026**

Constance Mellis (CMRPC) addressed the group; there will be changes coming in 2026 to the nature or operation of the advisory group. Currently, CMRPC is under contract to WRTA to staff TPAG and provide administrative services. When TPAG began it was one of the few outlets for paratransit riders to engage directly with the WRTA and make their voices heard. Today, there are many groups who do this including Worcester's Department of Transportation and Mobility, Riders Action Council, Transportation Advocacy Coalition, transportation advocacy being done at the Center for Living and Working, among others. Additionally, there is a Disability Rep and a Rider Rep on the WRTA Advisory Board who hold voting positions. Because of this, TPAG will see some changes in the coming year. The specific changes are unknown as of now. Attendees acknowledged the decreasing participation in the group. Attendees also expressed interest in a re-organization or re-purposing of the group, perhaps working within the other organizations and groups advocating for the same populations. Changes are expected to take place beginning Jan 2026.

### **WRTA Advisory Board Representatives**

Rider Representative (currently filled through Oct 2025)

The group was advised to begin discussions on who might be nominated for these positions which are going to be open soon. Mr. Kennedy, who is the current disability

representative on the WRTA advisory board, suggested that more disability and rider representatives could be added to the WRTA advisory board. He expressed concern about having one person be the sole voice for an entire community on the advisory board.

The meeting was adjourned after 45 Minutes.
