#### Timeline

- September 2023 April 2024 (8 Months)
  - Review of federal planning guidance and best practices
  - Public Involvement
- May 2024 June 2024 (2 Months)
  - Presentation to CMMPO Advisory Committee: March 27, 2024
  - Presentation to CMMPO: May 16, 2024 June 19, 2024 (tentative)
  - Public Review and Comment Period: June 3, 2024
    - Distribution of a flyer to announce availability of the document
  - CMMPO Endorsement: June 19, 2024, conflict with Juneteenth holiday, date to be determined
- 2024 2028 (4 Years)
  - ▶ Update Plan in 2028 with prioritizations ranked by time, feasibility, and available funding
  - Track new or ongoing Community Transit Grant Program projects
  - Develop implementation and evaluation metrics to measure progress

#### **Stories**

- Bus connections are necessary to cross the City and trips are time consuming.
- Short distance paratransit trips can take much longer because of ride sharing.
- Riders want to track paratransit vans and prefer early appointment reminders.
- Concerns about riders being able to cross the street safely to their destination.
- Sensory impairments and limited English are barriers to navigating the Hub.
- Issues with customer service and getting someone on the phone for late trips.
- Many bus stops are not cleared enough for people with mobility challenges.
- Free fares allow riders to save their limited resources on transportation costs.
- Paratransit users feel limited by operation hours and service area boundaries.
