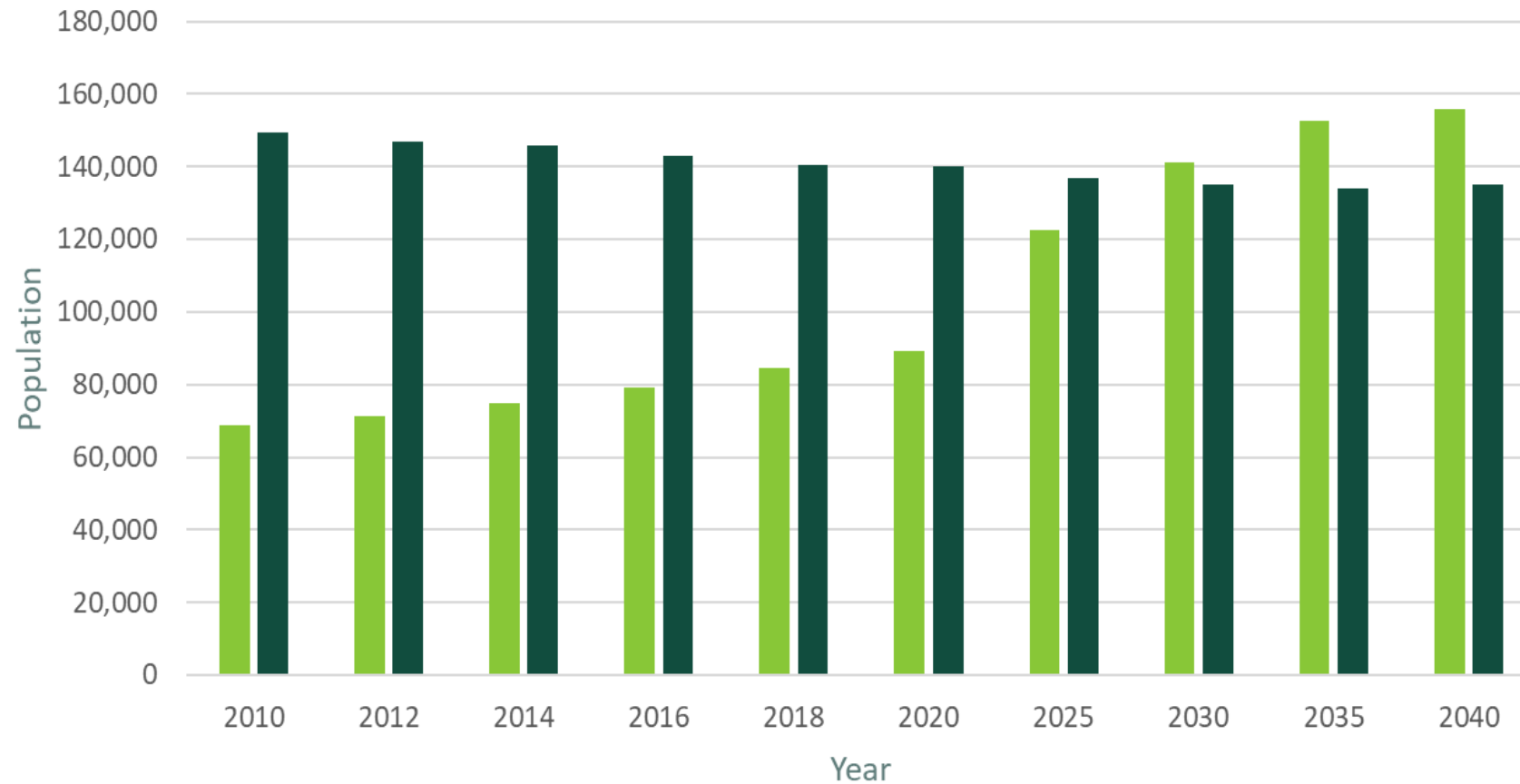
Background

- CMRPC's Regional Plan, Imagine 2050.



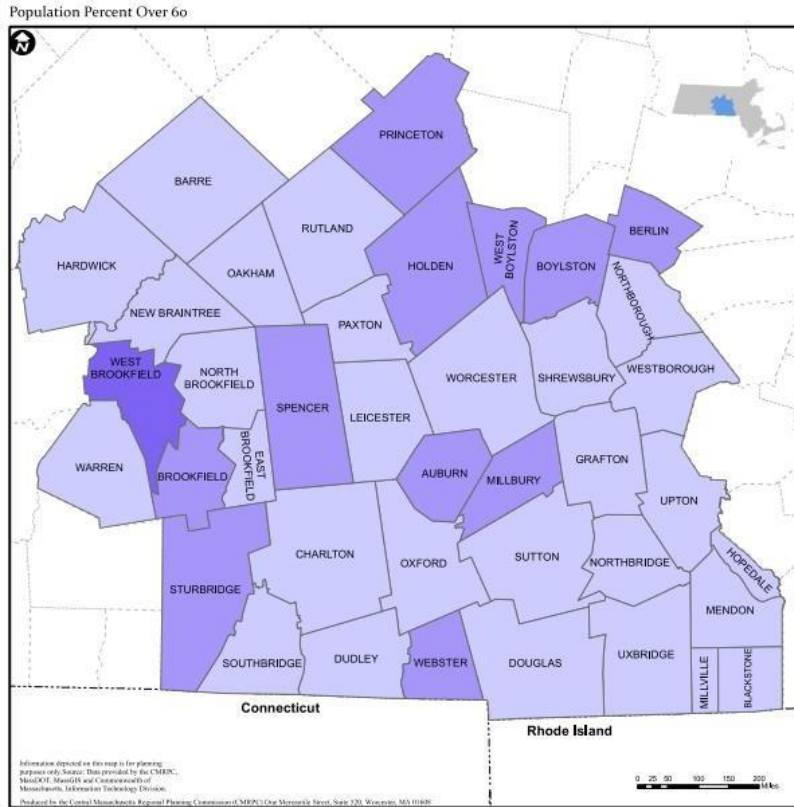
Older Adults & Children, 2010-2040

(CMRPC PLANNING REGION)

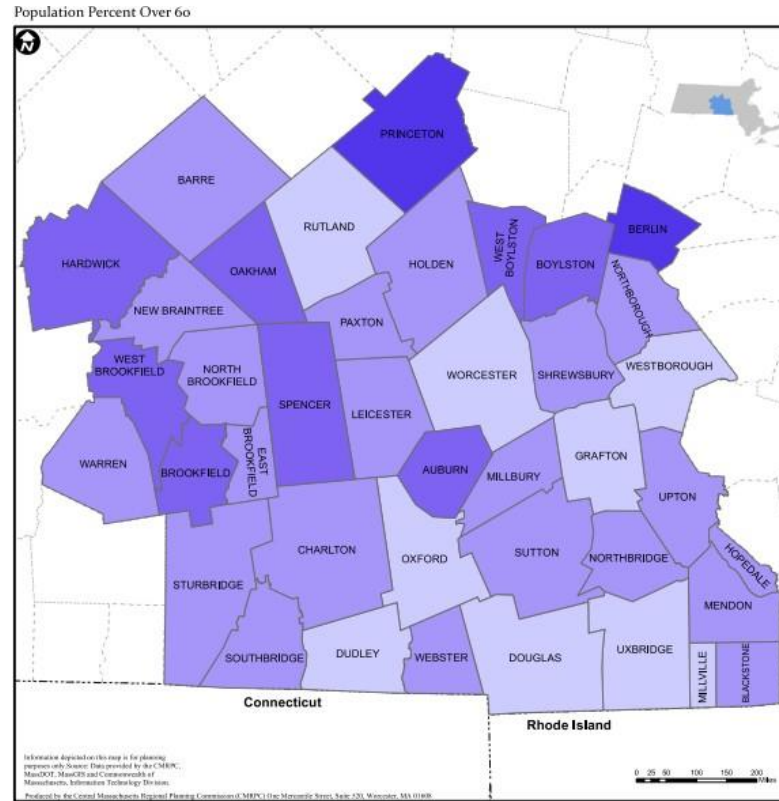

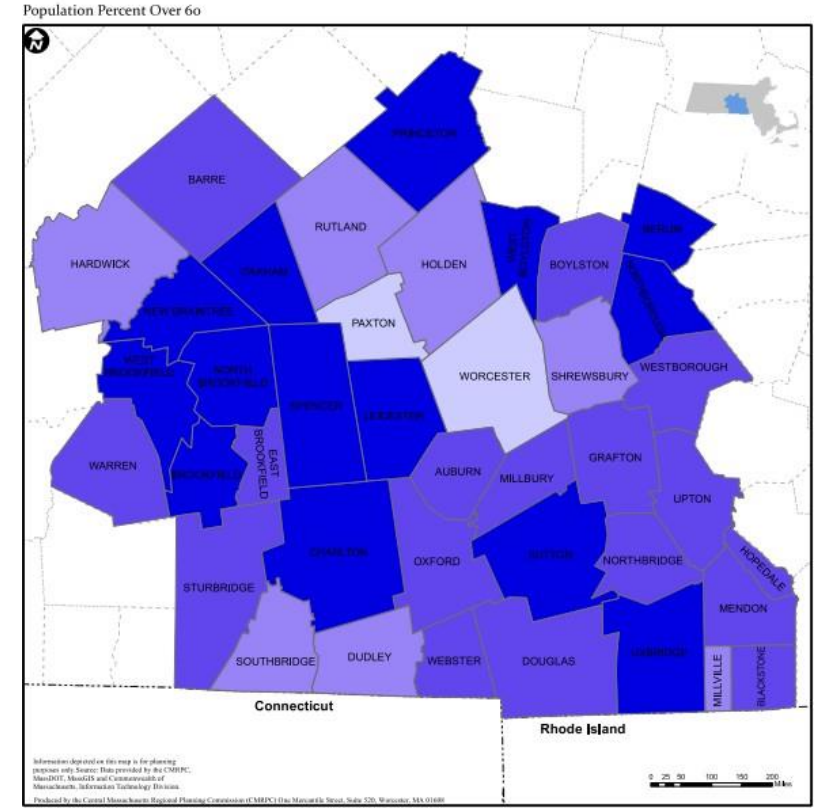

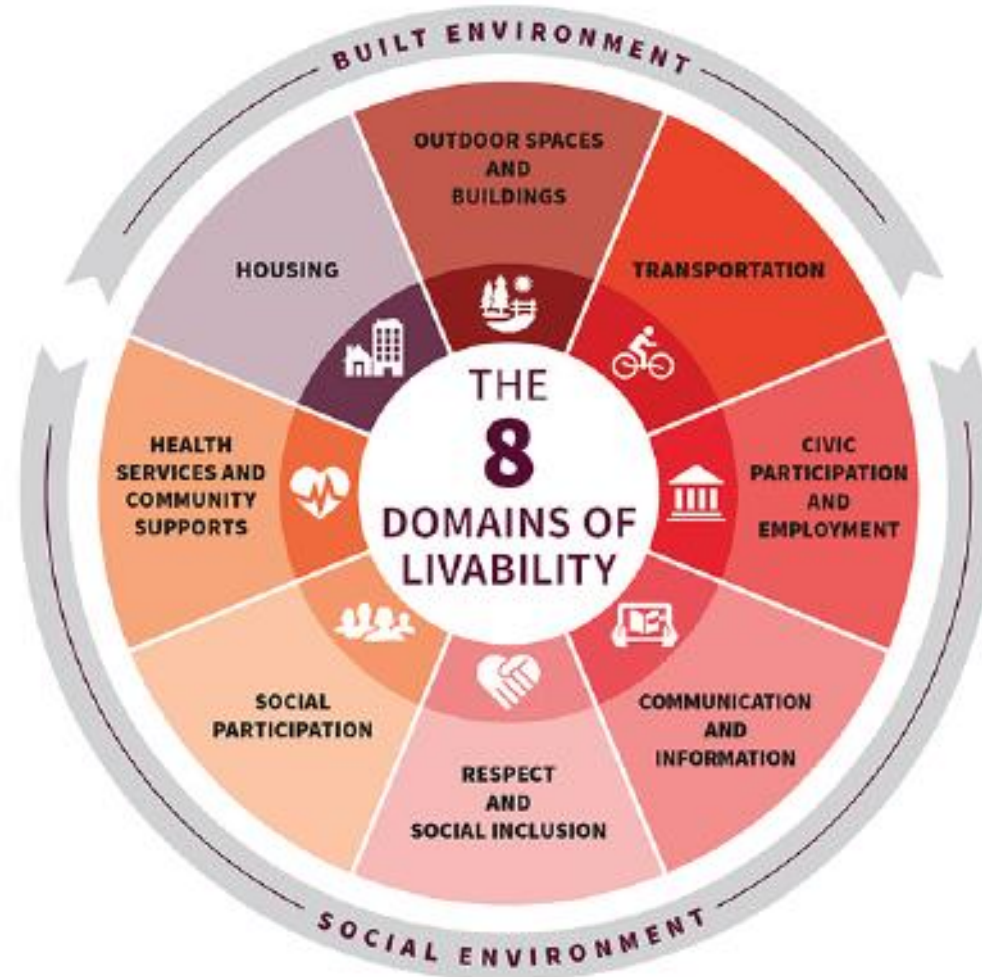
